1. Sealed quotations should be submitted into the tender dropping box in Ground floor at YPSA-Young Power in Social Action, Head Office, House# F10(P), Road# 13 , Block B , Chandgaon, R/A, Chittagong-4212.
2. Brief descriptions of procurement Item: **One (01) HIACE Ambulance**
Model: 2011
CC: 2000/2500 CC
Medical facilities: Oxygen cylinder, patient bed, with attendance seat, dual AC & Related others equipment's, Registration from appropriate authority. Registration should complete and supply the documents within 45 days upon delivery date of the ambulance.
3. Last date of Tender submission: 13.05.2017, by 5:00 PM.
4. Ambulance delivery date: 07 (seven) calendar days after receiving the purchase order from YPSA.
5. Quoted price should inclusive of applicable VAT and Tax which should be deducted from vendor's Invoice as per Govt. Rules (If importer directly supplied the Vehicle then import stage AIT can be claimed);
6. Condition of warranty provision or after sales service should be clearly mentioned in the submitted Quotation
7. Before supplying the ambulance, YPSA authority will visit the showroom for inspecting the quality however after delivery YPSA will check as per requirement.
8. Payment will be made by crossed cheque or bank-to-bank transfer in favor of the vendor after satisfactory delivery the ambulance

9. Security deposit: 3% of the total Purchase Order Amount to be deposited by the awarded vendor before signing the Purchase order through Bank Draft/Pay Order/ in favor of YPSA. This Security Deposit to be returned after satisfactorily completion of the delivery. Otherwise the deposited money shall be forfeited

10. Eligibility of Tenderer/vendor:

- a) The Tenderer shall have a minimum of 3 (three) years of overall experience in the supply of Ambulance/related accessories and service.
- b) Competitive financial offer
- c) The intending bidder shall have to provide the following in support of their eligibility:
 - Photocopy of valid Trade License
 - VAT Registration
 - TIN Certificate
 - Bank Solvency Certificate.
