1. The last date for dropping tender on **12/11/2024 by 3:00 p.m.**, and on the same date **3:30 pm** tender box will be opened.



2. The vendor(s) should submit the tender Schedule as per specifications along with the attached company details (**Annexure-1**).
3. Supply must be completed by seven days after getting the work order as per providing guidance/instructions from YPSA project team.
4. Supplier will be agreed to deliver goods at YPSA Head Office Chandgaon R/A, and YPSA Halishahar project office Chattogram.
5. The selected vendor will be agreed to bear the cost of delivery of the mentioned bins at 70 different locations of Chattogram City Corporation(CCC) area.
6. All bidders/vendors given rate should be considered transportation and relevant other cost.
7. Account payee cheque will be given after deduction of Govt. VAT and others after successfully compilation the supply of goods/items.
8. Child labor will not be allowed in carrying, loading & unloading, transportation etc. and Child labor also abide in your office and home. In this regard "YPSA Child Safeguarding Policy" will be followed during work with YPSA.
9. Supplier should send all legal documents like Trade License, AIT Certificate, TAX return copy of 2023-2024/last Assessment Year, BIN Certificate, NID Card copy (Both Side), Bank Solvency Certificate with Bank, Previous experience of purchase order/work order details.
10. There is no negotiation on the quality of goods/items.
11. YPSA will not be liable for any damage and accident during the carrying of goods
12. YPSA deserves the right to correct, modify, or reject any clause or all tender documents/work orders without showing any clarification.
